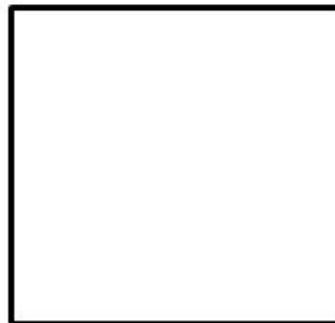

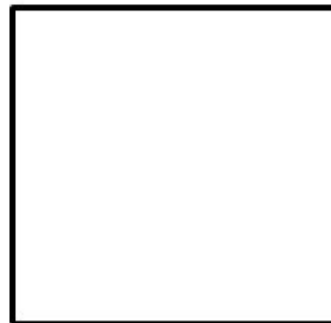

NOTES TO APPLICANT

1. Photograph

Photograph must be in colour and shall:

- (i) Be sharp and clear.
- (ii) Be taken within the last 3 months
- (iii) Be taken against plain white background
- (iv) Be taken full face with you looking directly at the camera, head straight with eyes open and no hair across and/or covering your eyes and eyebrows. Both edges of your face and the top of your shoulder must be clearly shown.
- (v) Be without headgear unless it is worn in accordance with your religious or racial customs and if it does not hide your facial features. The headgear should also not be white.
- (vi) Be without tinted glasses and sunglasses. If you wear glasses, the frames must not cover any part of your eyes or have flash reflection off the glasses.

2. Change of Particulars/ Address

A copy of supporting documents must be attached to the form:

- (i) Deed poll for any change of name, including secondary name and name in ethnic characters that are registered on the current NRIC.
- (ii) Religious Certificate (Baptism Certificate) for insertion of religious name;
- (iii) Acceptable documents for the change of address i.e. Property tax document.

3. Advice on Loss of NRIC

In the event that you subsequently recover your IC, there will be no refund provided.

4. Collection of NRICs

NRICs not collected within three months from the date of collection will be destroyed. No refund of the application fee will be given.

NRICs cannot be collected overseas. Please submit your application two weeks prior to your return to Singapore.

5. Submission of replacement application (with supporting documents)
