**SECURITY BOND**

Whereas application under the Immigration Regulations has been made for the grant of Visit Pass for the person whose particulars appear in the Schedule hereto:

And whereas a Visit Pass has been granted on the following conditions:

1. he/she shall comply with the provisions of the Immigration Act and any Regulations made thereunder or any statutory modification or re-enactment thereof for the time being in force in Singapore;
2. no extension of stay beyond the 1 month approved by the Immigration and Checkpoints Authority shall be sought either by him/her on his/her behalf;
3. he/she shall not get married during his/her stay in Singapore;
4. he/she shall not engage in any form of employment paid or unpaid, or in any business, profession or occupation, or in any activity which, in the opinion of the Controller of Immigration, is detrimental to the security, reputation and well-being of Singapore;
5. he/she shall not smoke, administer to herself or otherwise consume or be in any way engaged in the trafficking of any controlled drug as defined in the Misuse of Drugs Act (Chapter 185) or any written law for the time being in force relating to the control of dangerous or otherwise harmful drugs;
6. he/she shall not remain in Singapore after the expiry of the Visit Pass; and
7. no permanent stay shall be sought by her or on her behalf.

Now the above-written obligation is conditioned to be void upon the departure of the said person from Singapore in accordance with the aforesaid conditions.

But, in the event the said person shall be in breach of any or all of the aforesaid conditions, then this obligation shall be in full force and effect to the extent of \$ \_\_\_\_\_ to be paid by me.
