### (A) FORMS

- Completed Personal Particulars Form
- Thumbprint impression form, duly completed and notarized – Please ensure clear prints and roll prints are taken

### (B) PERSONAL INFORMATION

- Recent Photo taken in the last 6 months
- Singapore Birth Certificate – explanation letter if not furnished
- Singapore Identity Card – explanation letter if not furnished
- Singapore Passport or any other Singapore travel document– explanation letter if not furnished
- Deed Poll, Change of Name document, Baptism certificate (if applicable).
- Employer’s letter certifying occupation, salary, and date of joining.
- Education papers: - School report book, school leaving certificate, examination certificate, diploma, degree, testimonial, certificate of merits, etc
- Medical papers: - Certificate of Successful Vaccination, Certificate of Inoculation of child against Diphtheria, International Certificate of Vaccination or Revaccination against Cholera, International Certificate of Vaccination or Revaccination against Smallpox, Hospital discharge cards, etc
- Adoption certificate (if applicable)
- Doctor’s memo indicating current medical condition (if hospitalised)

### (C) RESIDENCY INFORMATION

- Letter from Foreign Authority indicating type of stay in the foreign country e.g. Citizen, PR, Visit pass etc or reason for detention.
- Documents pertaining to stay in Foreign Country e.g. Identity Card, Passport, Citizenship Certificate, Permanent Resident Card, Resident visa etc. Please ensure latest valid document information is submitted.
- A letter stating how you have continued to reside in the foreign country to-date and also an account of the events of your life while residing there including (i) when and how did you enter the foreign country (ii) using what travel document (iii) who you are currently residing with in the foreign country
- A letter stating the reason for departure from foreign country and plans after departing foreign country
