Local applicants may authorise a representative to collect his/her Certificate of Identity (CI) (refer to Part V).
 2. An application in respect of a person below 16 years of age must be signed by the Parent/Legal Guardian (refer to Part III).
 3. Two recent photographs of the applicant are required, one of which must be affixed to the form.
 4. ICA may issue a CI of 5-year or a shorter duration after assessing the applicant's eligibility. The fee for such a CI is S\$25/- per year or part thereof.
 5. Estimated time to complete this application form is about 10 minutes.
