EXPLANATORY NOTES FOR RENUNCIATION OF SINGAPORE CITIZENSHIP

(A) ELIGIBILITY

A citizen of Singapore can only renounce his/her Singapore citizenship if he/she:

- Is aged 21 and above;
- Is of sound mind; and
- Has acquired the citizenship of another country

(B) REQUIRED DOCUMENTS

Please **return** the following documents to ICA:

- Original Singapore Identity Card (IC)
 - If you have lost this document, please submit the Thumbprint Impression Form VI and Statutory Declaration Form VII
 - For laminated IC holders, please submit Thumbprint Impression Form VI
- Valid Singapore Passport
(If you have lost this document, please submit the Statutory Declaration Form VIII)
- Original Singapore Citizenship Certificate (for Singapore Citizens by descent or registration)
(If you have lost this document, please submit a Letter of Explanation Form IX)

Please submit a **certified true copy** of the following documents*:

- Valid Foreign Passport
- Foreign Citizenship Certificate
- Deed poll / Change of Name Certificate / Religious/ Baptism Certificate / Marriage Certificate
If there had been a change of name, please also submit Thumbprint Impression Form VI

*Note for above documents:

- Document must be duly notarized by a Notary Public, Justice of the Peace or Commissioner for Oaths (with his/her Official Seal/ Stamp affixed / Appointment letter) or Consular Officer of Singapore
- Documents that are not printed in the English language **must be officially translated into English**. ICA accepts:
 - Translations provided by any Notary Public or the Embassy of the document-issuing country.
 - A privately translated copy certified by the Embassy of the document-issuing country or notarized by a local Notary Public.

(C) REQUIRED FORMS

The Forms may take approximately 30 minutes to complete. Please note the following:

- Countersign next to any amendments made on the forms.
- **DO NOT** use correction fluid on the form.

****Note for Statutory Declaration** – Document must be duly notarized by a Notary Public, Justice of the Peace or Commissioner for Oaths (with his/her Official Seal/ Stamp affixed / Appointment letter) or Consular Officer of Singapore

(D) FEES AND SUBMISSION MODES

A S\$35 processing fee is payable and can be submitted with the Forms and Documents via:

- Singapore Overseas Missions**
- By Post** – Accepted Payment modes - Cheque/ Money Order/ Bank Draft.

Please ensure:

- it can be drawn from any local bank in Singapore,
- it is made payable to “Commissioner ICA”. (The payee name should be written clearly and neatly. Any illegible handwritings will not be accepted.)

- At ICA Building** –
 - Payment modes - Nets, Flashpay, Credit Card, Amex.
 - Forms and Documents can be submitted in person or by authorised proxy

(E) PROCESSING TIME

The general processing time is approximately three (3) months from receipt of complete forms and documents. Some applications may require a longer processing time.

Dear Sir / Madam,

RENUNCIATION OF SINGAPORE CITIZENSHIP

We wish to advise you to consider carefully before you renounce your Singapore citizenship. Once your declaration of renunciation is registered, you cease to be a citizen of Singapore and there is ***no provision for reinstatement***. There is also no assurance that you can continue studying, working or residing in Singapore as a foreigner on any form of student pass, work pass, social visit pass or as a permanent resident.

- I require a two-month* cooling off period after which ICA may proceed with my renunciation application.

***No extension of cooling off period will be granted.** If you require more time to reconsider your renunciation decision, please submit a withdrawal request before your selected cooling off period ends. There will be no refund of renunciation fee for withdrawals.

RENUNCIATION OF SINGAPORE CITIZENSHIP

1. Singapore citizenship confers upon a person privileges such as the possession and use of the Singapore passport. These privileges come with responsibilities, such as serving National Service (NS). NS is vital to the defence and security of Singapore. Under the Enlistment Act, male Singapore citizens and Permanent Residents are liable for NS.
2. We would like to inform you that under Article 128(2) of the Constitution of the Republic of Singapore, the Government may reject a person's application for renunciation of Singapore citizenship if he is subject to the Enlistment Act and has not discharged his NS liability.
3. Those who are allowed to renounce their Singapore citizenship without serving NS will face serious adverse consequences in their immediate or future applications to work, study or live in Singapore. They will not be granted Permanent Resident status or citizenship in the future.
