Immigration Offender Situation

Number of Immigration Offenders Arrested Continued to Decline.

Last year, the Immigration & Checkpoints Authority (ICA) arrested 1,901 immigration offenders (IOs), a decrease from 2,040 in 2014.

2. The number of illegal immigrants arrested fell about 11% from 350 in 2014 to 310 in 2015. The number of overstayers arrested also dropped about 6% from 1,690 in 2014 to 1,591 last year.

3. ICA's sustained tough enforcement and proactive public education against illegal immigrants and overstayers have resulted in a steady decline in the number of IOs in Singapore.

4. As undocumented persons, IOs pose potential law and order as well as security problems. ICA will continue to take a strong stance against them.

Harbouring and Employment of Immigration Offenders

Number of Harbourers and Employers of IOs Rose Significantly.

5. In 2015, 416 harbourers and 91 errant employers were arrested for providing lodging or work to IOs. The number arrested has increased by 59% as compared to 2014.

6. The increase in the number of harbourers and errant employers arrested can be attributed to ICA's focused and coordinated enforcement efforts, which were conducted in close collaboration with other enforcement agencies such as the Police and the Ministry of Manpower.

7. Almost half of the harbourers arrested last year were Singaporeans. The errant employers who engaged IOs came from various industries such as construction, food and beverage and cleaning services.

8. Everyone has a role to play in ensuring the safety and security of Singapore. Homeowners and employers should not offer shelter or employment to IOs. Without the prospect of illegal employment or shelter, IOs would not find Singapore attractive.

Outreach to the Community

The Safety and Security of Our Community is a Collective Responsibility.

9. ICA continues to work closely with our community partners to keep Singapore safe and secure. ICA ambassadors reach out to homeowners and estate agents on the need to conduct necessary checks on potential tenants. Awareness talks were also carried out at work sites to remind foreign workers of the serious consequences of overstaying in Singapore.

10. In addition, ICA has continued to reach out to households by distributing the Homeowners' Guide. The purpose is to alert homeowners to carry out due diligence by checking the legal status of their foreign tenants before agreeing to rent out their premises.

Contraband Smuggling Situation

Slight Increase in Number of Contraband Cases Detected.

11. The number of contraband cases detected at our checkpoints increased about 2% from 93,380 in 2014 to 95,677 in 2015. Despite stringent checks at the borders, smuggling attempts have not abated.

Emerging Trend

12. With online shopping becoming more popular with Singaporeans, the smuggling of contraband items via parcels and packages shipped into Singapore is increasing. The number of contraband cases detected in parcels and packages increased from 14,289 in 2014 to 18,419 last year.

13. Some of the common contraband articles detected included stun guns and sex enhancement pills. The public are reminded not to import prohibited goods or controlled items without the approval of the relevant authorities. 14. ICA will continue to conduct stringent checks on passengers and vehicles at the checkpoints to prevent attempts to smuggle undesirable persons, drugs, weapons, explosives or other contraband items.

Marriage of Convenience

Significant Drop in the Number of Persons Arrested for MOC.

15. Fewer people are being convicted for marriage of convenience (MOC) offences last year. Some foreigners enter into an MOC in order to stay in Singapore and find work here, while Singaporeans who enter into such bogus unions do so for monetary gains. Entering into an MOC is illegal.

16. ICA takes a tough stance against couples and middlemen trying to circumvent the law by engaging in MOC so as to obtain immigration facilities in Singapore. In 2012, the act of arranging or entering into a MOC was criminalised. The law and heavy penalties against MOC have been effective in deterring would-be offenders.

17. ICA will spare no effort to go after such persons by pursuing every available lead. We welcome members of public to report any suspected case of MOC as well as other immigration related offences to ICA at 1800-391-6150. Any information provided will be treated in the strictest confidence.
